# **Intended** Use

The DASH SARS-CoV-2/S Test is a real-time RT-PCR assay intended for the qualitative detection of RNA from SARS-CoV-2 in direct anterior nasal swab specimens from individuals suspected of COVID-19 by their healthcare provider. Testing is limited to laboratories certified under the Clinical Laboratory Improvement Amendments of 1988 (CLIA), 42 U.S.C. §263a, that meet the requirements to perform high, moderate, or waived complexity tests. The DASH SARS-CoV-2/S Test is authorized for use at the Point of Care (POC), i.e., in patient care settings operating under a CLIA Certificate of Waiver, Certificate of Compliance, or Certificate of Accreditation.

Results are for the identification of SARS-CoV-2 RNA. The SARS-CoV-2 RNA is generally detectable in anterior nasal specimens during the acute phase of infection. Positive results are indicative of the presence of SARS-CoV-2 RNA; clinical correlation with patient history and other diagnostic information is necessary to determine patient infection status. Positive results do not rule out bacterial infection or co-infection with other viruses. The agent detected may not be the definite cause of disease.

Negative results do not preclude SARS-CoV-2 infection and should not be used as the sole basis for patient management decisions. Negative results must be combined with clinical observations, patient history, and epidemiological information.

Laboratories within the United States and its territories are required to report all test results to the appropriate public health authorities.

The DASH SARS-CoV-2/S Test is intended for use by health professionals or trained operators who are proficient in using the DASH Analyzer. The DASH SARS-CoV-2/S Test is only for use under the Food and Drug Administration's Emergency Use Authorization.

# Summary and Explanation

Coronavirus disease 2019 (COVID-19) is a potentially fatal respiratory illness caused by the novel human coronavirus SARS-CoV-2 (severe acute respiratory syndrome coronavirus 2) which has resulted in significant worldwide morbidity and mortality. In March 2020, The World Health Organization declared COVID-19 a global public health emergency.

DASH SARS-CoV-2/S Test uses reverse transcriptionquantitative polymerase chain reaction (RT-qPCR) for rapid qualitative detection of SARS-CoV-2 from anterior nasal swabs. The DASH platform enables the performance of the DASH SARS-CoV-2/S Test at the point-of-care or in clinical laboratory settings.

# Principle of the Procedure

The DASH SARS-CoV-2/S Test combines the technologies of sequence specific capture sample prep and RT-qPCR amplification. The DASH SARS-CoV-2/S Test Cartridge contains all reagents necessary to perform the test. An anterior nasal with a 30-mm breakpoint is used to collect a specimen. The nasal swab specimen is added to the DASH SARS-CoV-2/S Test Cartridge sample chamber containing lysis buffer which releases the RNA target from the virus. The operator breaks off the swab at the 30-mm breakpoint, and the Cartridge is capped and inserted into the DASH Analyzer to initiate the test. All subsequent test steps are performed automatically by the DASH Analyzer.

The target RNA molecules are isolated from specimens by use of capture oligomers via target capture that utilizes paramagnetic particles. The biotinylated capture oligomers contain sequences complementary to specific regions of the target molecules. During the hybridization step, the sequence specific regions of the capture oligomers bind to specific regions of the target molecules. The capture oligomer:target complex is then concentrated by the addition of streptavidincoated paramagnetic particles. The paramagnetic particles including the bound target molecules are washed to remove residual specimen matrix that may contain amplification reaction inhibitors. After the target capture steps are completed, the target RNA is ready for amplification.

The RT-qPCR assay targets two regions of the Nucleocapsid protein (N) gene that are unique to SARS-CoV-2. The two regions are not differentiated, and the amplification of either one or both targets leads to fluorescent signal. A process control is also included to control for adequate processing of the target virus through steps of sample purification, nucleic acid amplification and to monitor for the presence of inhibitors in the RT-qPCR test.

# **Reagents and Analyzer**

The DASH SARS CoV-2/S Test contains sufficient reagents to process 12 specimens or quality control samples.

Store the DASH SARS-CoV-2/S Test Cartridges and DASH Analyzer at 15-30°C.

DO NOT open Cartridge Cover #1, until you are ready to perform testing.

DO NOT use a Cartridge that is wet or has leaked.

- **1.** Before performing this test, read the DASH SARS-CoV-2/S Test Instructions for Use completely.
- 2. For Use Under an Emergency Use Authorization (EUA) Only.
- Store DASH SARS-CoV-2/S Test Cartridges and DASH Analyzer at room temperature (between 15°C and 30°C)
- 4. Operate the DASH Analyzer on a level surface
- 5. DO NOT use a Cartridge that is wet or has leaked.
- 6. DO NOT use a Cartridge whose top Covers #1 and #2 are not intact.
- 7. DO NOT use a Cartridge that has been dropped.
- **8.** DO NOT open Cartridge Cover #1, until you are ready to perform testing.
- **9.** DO NOT open Cartridge Cover #2, until you are ready to insert Cartridge into the Analyzer.
- 10. Run cartridge immediately after Cartridge Cover #2 is removed.

# Sample Collection, Transport and Handling

#### **Specimen Collection and Handling**

Inadequate specimen collection or improper sample handling/storage/transport may yield erroneous results. Refer to the CDC Interim Guidelines for Collecting, Handling, and Testing Clinical Specimens from Persons for Coronavirus Disease 2019 (COVID-19).

#### Anterior Nasal (Nares) Swab

Only the swab provided in the kit is to be used for nasal swab collection. Insert the entire collection tip of the swab provided (usually ½ to ¾ of an inch, or 1 to 1.5 cm) inside the nostril. Firmly sample the nasal wall by rotating the swab in a circular path against the nasal wall at least 4 times. Take approximately 15 seconds to collect the specimen. Be sure to collect any nasal drainage that may be present on the swab. Repeat in the other nostril using the same swab. Place swab, tip first, into the swab container provided.

#### **Specimen Transport and Storage**

Direct anterior nasal swabs can be stored at room temperature (15-30°) for up to 48 hours until testing is performed on the DASH analyzer.

# **Quality Control - Internal Controls**

The DASH SARS-CoV-2/S Test Cartridge contains a positive procedural armored RNA® control (non-infectious RNA encapsulated in MS2 bacteriophage) that is used to verify assay steps including viral lysis, RNA extraction, and nucleic acid amplification and detection were executed properly and without sample derived inhibition. The Procedural Control will display Valid on the results screen in a SARS-CoV-2 negative sample or SARS-CoV-2 positive sample. The Procedural Control is Valid if it meets the validated acceptance criteria.

# **Quality Control - External Controls**

Controls must be used to show that the DASH SARS-CoV-2/S Test is working properly. The DASH SARS-CoV-2/S Test Positive Control Swab and DASH SARS-CoV-2/S Test Negative Control Swab are available separately.

The DASH SARS-CoV-2/S Test Positive Control (Ref 0314P) and Negative Control (Ref 0315N) Swabs must be stored at room temperature (between 15°C and 30°C). Controls are tested using the same procedure as for a patient sample.

It is recommended that external controls be tested at the frequency noted below.

- Each time a new lot or a new shipment of DASH SARS-CoV-2/S Test is received.
- · Each time a new operator is performing the test.
- When the Analyzer is used for the first time.
- When the software is upgraded.
- · When problems are suspected or identified.
- As deemed additionally necessary by internal quality control procedures, and in accordance with Local, State and Federal regulations or accreditation requirements.

If correct control results are not obtained, repeat the test using a new Control Swab, and a new test Cartridge. If the control testing continues to fail, do not perform additional clinical specimen tests or report results. Contact technical support at techservice@m2dx.com or 1-888-992 DASH.

# The DASH System

The DASH System is built around an automated analyzer, which extracts specimens and performs nucleic acid amplified tests (NAAT) in assay Cartridges. It is connected to a barcode reader, which scans specimen and Cartridge labels, and a thermal printer that outputs reports. A tablet computer is used to configure the DASH Analyzer settings and review test results. The tablet computer can be disconnected and stored away when not in use.

The DASH Analyzer should be setup on a clean and level surface at least 4 feet wide and 2 feet deep. Three 120VAC outlets are required where power adapters for the analyzer, printer and tablet can be plugged in. Only use Minute Molecular supplied charging cable and power adapter.

The environmental conditions for operating DASH SARS-CoV-2/S Test are 15-30°C, 20%-80% relative humidity.

# 1. Unpacking Instructions

Take all components out of their shipping containers and identify them to be sure you have received everything.

To Unpack, read the steps below and watch the following **tutorial video**:



#### 1.1 Unpack the DASH Analyzer

Take hold of the top of the DASH Analyzer and lift it out of its shipping container. Then, remove the protective wrapping.



Place the DASH Analyzer in the center of a level surface at least 2 feet deep and 4 feet wide. There should be three 120VAC power outlets to plug in the DASH Analyzer, the Printer, and the Tablet.



#### 1.2 Unpack the Accessories

The Accessories Shipping Carton contains the Epson Printer, the DASH Power components, and the Ethernet components.



**1.2.1** Unpack the DASH Analyzer power adapter and power cord



The DASH Analyzer power adapter has the XP Power logo on it.

**1.2.2** Unpack the barcode scanner and USB printer cable



1.2.3 Unpack the Ethernet adapter and Ethernet cable



**1.2.4** Unpack the Epson Printer box and unbox the printer, power adapter and power cord



One roll of **thermal paper** is shipped in the printer.

Additional paper can be ordered in cartons of 10 rolls.

#### 1.3 Unpack the PC Tablet

Open the Microsoft Surface Pro box and unpack the tablet, power adapter, and power cord.



# 2. Installation and Set-Up

After unpacking and identifying all the components, set up the printer, barcode scanner, Ethernet connection and PC tablet.

#### Warning: DASH Analyzer must be located on a level surface.

Place the DASH Analyzer on the right side of your work area an angle with the back side facing to the left and forward. To the left of the DASH Analyzer, place the printer upside down. To the left of the printer, place the tablet. The power adapters should be placed behind the units. The barcode reader can be placed in the front.

The system is most easily set up by as shown in the picture below:



To Set Up, follow the steps below and watch the following **tutorial video**:



#### 2.1 Set-Up the DASH Analyzer

Turn the DASH Analyzer so the back side is facing forward to make it easier to plug in cables.



**2.1.1** Connect the DASH Analyzer's power adapter to the round socket on the back of the DASH Analyzer. The flat side of the plug should be down.



Connect the power cord to the adapter, then place it behind the DASH Analyzer.

**2.1.2** Connect the barcode reader to any one of the USB ports and set it in front of the work area.



#### 2.2 Set-Up the Printer

Turn the printer upside down so it's easier to plug in the cables.

**2.2.1** Insert USB cable's square plug into the printer's square socket, with the USB connect icon facing the bottom of the printer.



**2.2.2** Plug the other side of the USB cable into the back of the DASH Analyzer.

**2.2.3** Insert the round Plug of the Power Adaptor cable into the printer.



The flat side with the arrow should face the bottom of the printer

**2.2.4** Plug the Power Cord into the Power Adapter.



Turn the printer right side up.

2.2.5 Plug power cord into 120VAC outlet



#### 2.2.6 Power up the printer

Push the white dot side of the power switch on the front of the printer



Green LED on the top right side will illuminate when power is on

#### 2.2.7 Check thermal paper

Open the lid by pressing on the grey button on the right side of the printer



Note that the end of the roll of thermal paper is feeding from the bottom towards the front. Pull the end to unroll 6 inches paper.



Close the Printer lid.

Tear off excess paper by pulling it forward over the tear bar and slightly to the side.



#### 2.3 Set-Up the PC Tablet

The PC Tablet should be placed on the left side of DASH Analyzer where it is connected with the DASH Analyzer through the Ethernet cable. It is also connected to a power adapter that is plugged into 120VAC.

**2.3.1** Place the tablet on the left side of DASH Analyzer and pull out the kickstand to have the screen at a 45° angle. Adjust the angle to minimize glare and facilitate typing on the screen.



**2.3.2** Plug one end of the Ethernet cable into the USB-Ethernet adapter and the other end into the socket on the left side of the back panel of the DASH Analyzer



**2.3.3** Plug the other end of the USB-Ethernet Adapter to the USB port in the side of the tablet.



**2.3.4** Connect the power adaptor cord to the socket on the side of the tablet. Connect the Power Cord to the Power Adaptor and plug it into 120VAC.



#### 2.4 Arrange system components

- Turn the DASH Analyzer around so the display is facing the operator.
- The Printer and Barcode scanner should be to the left of the DASH Analyzer.
- The power adapters should be placed behind the printer and DASH Analyzer.
- Plug the DASH Analyzer Power Cord into a grounded 120VAC outlet.
- Fold up excess lengths of all cables and secure them with cable ties.



#### 2.5 Start-Up the DASH Analyzer

To Start Up, follow the steps below and watch the following **tutorial video**:



#### 2.5.1 Power Up

Press the power button in the center of the DASH Analyzer's Clock Lights.



**On Backside:** (3) USB Connections; (1) Ethernet Port; and Power Connection

The operating system will boot up, displaying a series of screens.

#### 2.5.2 Eject shipping Cartridge

After initialization is completed in approximately 55 seconds, the DASH Analyzer will display an "Eject Cartridge" button. Press it, and door will slide open, and the Cartridge will be ejected. Remove the shipping Cartridge from the carrier and place it in the shipping container.

Note: The shipping Cartridge should be reinstalled whenever the DASH Analyzer is shipped. To reinstall the shipping Cartridge, scan the barcode of the shipping Cartridge, touch Open on the DASH Analyzer, and insert shipping Cartridge.

#### 2.5.3 Warmup

After the shipping Cartridge is removed, the DASH Analyzer will begin warming up by turning on its heaters. When they reach their preset temperatures in approximately 80 seconds, operators can login and begin processing Cartridges.

#### 2.5.4 Start-Up the Tablet

Users with Admin privileges can make changes to some of the DASH Analyzer's settings, including assigning users and user pins assigned to the DASH Analyzer, through the Tablet app.

#### **2.5.5** Turn on the Tablet's power

After starting up the DASH Analyzer, the Tablet can be started up by pressing the button on the top left edge of the frame.



The Windows 10 operating system will begin booting up and display its lock screen. To enter the Windows password, swipe up on the lock screen.

The Windows user has been preassigned a name relevant to the system's owner, which you'll see highlighted in the bottom left corner.

The password has also been preassigned to the system's owner.

Enter the appropriate password and the Windows home screen will be displayed.

The Tablet has been preset to be in the Tablet Mode, so actions are initiated with a single touch instead of a double click, which is the more familiar Desktop Mode.

**2.5.6** Open the DASH Connect App Start the app by pressing its icon.



When the welcome screen shows, press the Open button.

To add a user:

- Role: Select a role, 'Admin' or 'User', for the new user of the DASH Analyzer
- UserID: Enter a User ID that will be displayed on the DASH Analyzer.
- PIN: Assign a 4-digit, numeric code. The user will have to select their UserID and enter their 4-digit PIN when running a test on this DASH Analyzer. Please make notes of the UserIDs and PINs for later use on the DASH Analyzer. After Role, UserID, and PIN have been filled, the "Save" button will turn green.
- ID Barcode: This field is optional. If User will have a scannable barcode ID, then type the ID in this field.

#### 2.5.10 Save your UserID and PIN

After clicking the "Save" button, a pop-up window will appear to notify the user that to update the Analyzer with changes go to the Home Menu screen.

# 3. Running QC Samples

To see how to run a QC test, follow the steps below and watch the following **tutorial video**:



# 3.1 Put on gloves (PPE) and gather materials needed to run a QC Test.

Identify the boxes (example below) labeled as SARS-CoV-2/S QC Negative control (REF 0315N) and SARS-CoV-2/S QC Positive Control (REF 0314P).



Pick either a SARS-CoV-2/S QC Negative (top) control or a SARS-CoV-2/S QC Positive (bottom) control, as pictured below, from the respective box. Note these Negative and Positive controls are in white packaging.



Next, identify the Cartridge boxes (REF 0121S) labeled as SARS-CoV-2/S (pictured below).

**3.2** When the DASH Analyzer is switched on, or after another User has logged out, the drop down list of username will be displayed. Select the username, and enter the 4-digit PIN and touch "Enter". If assigning IDs and Pins for the first time, see 2.5.8.

Your username is now shown in the header. Available tests are shown in the main section. The Analyzer will then warm up.



**3.3** Scan the SARS-CoV-2/S QC Negative Control or a SARS-CoV-2/S QC Positive Control QC swab packaging by holding down the button on the barcode reader. Note the bar code reader should be about 5-6 inches from the item being scanned.







After scanning the QC control, the specimen ID is shown in the window.

#### 3.4 Remove Cartridge from the silver packaging

Next, remove the Cartridge from the silver packaging and scan the Cartridge Barcode. Note the bar code reader should be about 5-6 inches from the item being scanned.



Once cartridge is removed from the silver packaging it should be run immediately.

Please note the correct way to handle the Cartridge



**3.5** Prepare the SARS-CoV-2/S QC Negative control or a SARS-CoV-2/S QC Positive Control QC Swab for USE in the cartridge.

Follow the instruction on the screen of the DASH Analyzer to prepare the specimen QC control swab for the Cartridge.

Please note the key areas of the Cartridge in the illustration below.

Swabs have two parts, a Swab Container and Swab with a 30 mm Breakpoint, as pictured below.



#### NOTE: Swabs in the kit are for use with DASH SARS CoV-2/S Test. Do not use other swabs.

#### 4.2 Collect anterior nares sample

Insert the entire collection tip of the swab provided (usually ½ to ¾ of an inch, or 1 to 1.5 cm) inside the nostril. Firmly sample the nasal wall by rotating the swab in a circular path against the nasal wall at least 4 times. Take approximately 15 seconds to collect the specimen. Be sure to collect any nasal drainage that may be present on the swab. Repeat in the other nostril using the same swab. Place swab, tip first, into the swab container provided.



#### 4.3 Run a DASH SARS-CoV-2/S Test

When the DASH Analyzer is switched on, or after another User has logged out, the drop down list of username will be displayed. Select the username and enter the 4-digit PIN and touch "Enter". If assigning IDs and pins for the first time, see 2.5.8.

# 5. Logging Out and Shutting Down

When a user is done running tests, they should sign out by touching the Log Out button. They will no longer be the active user and the button will change to Log In. DASH Analyzer will remain warmed up in a standby state for 2 hours. After that, if no one has logged in, the DASH Analyzer will go into a low power standby state.

If an operator knows that no more tests will be run for the day, they should shut down the DASH Analyzer. This is done by pressing the Power button, which then displays the Shut Down button. Touching it causes all of the DASH Analyzer internal power to be turned off.

DASH Analyzer should only be unplugged after it has been shut down and all power turned off.

# 6. Editing Settings and Viewing Reports

Users with Admin privileges can make changes to some of DASH's settings through the Tablet via DASH Connect App. The DASH Connect App can also be used to view results. To access the Admin privileges, Users must log into the Tablet and the DASH Analyzer must be turned on. The Admin should not be logged in to the DASH Analyzer.

#### 6.1 Start-Up the Tablet

#### 6.1.1 Turn on the Tablet's power

After starting up the DASH Analyzer, the Tablet can be started up by pressing the button on the top left edge of the frame.



The Windows 10 operating system will begin booting up and display its lock screen. To enter the Windows password, swipe up on the lock screen.

The Windows user has been preassigned a name relevant to the system's owner, which you'll see highlighted in the bottom left corner.

The password has also been preassigned to the system's owner.

Enter the appropriate password and the Windows home screen will be displayed.

The Tablet has been preset to be in the Tablet Mode, so actions are initiated with a single touch instead of a double click, which is the more familiar Desktop Mode. **6.1.2** Open the App Start the app by pressing icon

- The "Reports" button takes the user to the Reports screen.
- The "Users" button takes the user to the Users list screen.
- The "Sites" button takes the user to the Sites list screen.
- The "Update" button, when active, will update the connected Analyzer with any user or site information changes. It becomes active when a user changes the User content or Site information. Note: when the Analyzer is updated it will reboot for the changes to take effect.
- The "Organization" button takes the user to the Organization Information screen.
- The "Assays" button takes the user to the Assays list screen.
- The "Connect" button takes the user to the Connect screen to select the Analyzer to set up.
- The "Settings" button takes the user to a screen allowing the user to change the date and the time.

#### 6.2 Display Reports

To review historical test results, press the "Reports" button on the Home Menu screen. The Reports List screen is shown below. It allows the user to view reports and export them. The columns of the data on the table include Specimen ID, Test Date, Result, LOT, User ID, REF, Assay Name, and Specimen Type.

# Limitations

- Performance of the DASH SARS-CoV-2/S Test has only been established in direct anterior nasal swab specimens. Use of the DASH SARS-CoV-2/S Test with other specimen types has not been assessed and performance characteristics are unknown.
- A false negative result may occur if a specimen is improperly collected, transported or handled. False negative results may also occur if inadequate numbers of organisms are present in the specimen.
- The performance of this test was established based on the evaluation of a limited number of clinical specimens. # **Performance Characteristics**

### **Analytical Performance**

#### Analytical Sensitivity (Limit of Detection)

Samples containing heat-inactivated SARS-CoV-2 virus (USA\_WA1/2020, lot 70037779, BEI Resources, NR-52286) were tested at 50 copies/swab, 100 copies/swab, and 150 copies/swab in a range finding study by pipetting 20 µl of natural nasal swab clinical matrix contrived with heat inactivated SARS-CoV-2 virus onto nasal swab before testing in DASH SARS-CoV-2/S Test cartridge.

150 copies/swab was identified as the preliminary LoD. Twenty replicates of 150 copies/swab were tested and detected which verified that 150 copies/swab is the confirmed LoD. The results of the two studies are summarized below:

#### Analytical Reactivity (Inclusivity)

*In silico* analyses were performed using the RADx ROSALIND DXM online tool (https://radx.onramp.bio) to compare the DASH SARS-CoV-2/S Test primer and probe sequences for the N1 and N2 assays and the sequence specific capture probes to all SARS-CoV-2 sequences available in the ROSALIND database. The RT-qPCR oligonucleotide analysis was performed on February 17, 2022, and the capture probe analysis was performed on February 12, 2022. The sequences deposited in the previous 30 days before the analysis were also analyzed to report on recent trends in the data. The sequences used in the comparison are updated weekly from the GISAID Initiative by the ROSALIND tool. The potential impact of any oligonucleotide mismatch of a frequency greater than 0.1% was evaluated by calculating the predicted change in oligonucleotide Tm by comparing the oligonucleotide's Tm with and without the mutation in question using the nearest-neighbor two-state model. A sequence was considered at risk of reduced detection if the mismatch reduced the oligonucleotide's Tms at or below the PCR or the sequence specific capture hybridization temperature. 7,381,624 sequence were analyzed, and none of the sequences were predicted to have a risk of reduced detection. The results are presented in Tables below.

Delta (B.1.617.2, AY.1, AY.2, AY.3) and Omicron (B.1.1.529, BA.1, BA.2) variants are classified as circulating variants of concern (VOC). An in silico analysis of these variants was performed using the RADx ROSALIND DXM online tool (https://radx.onramp.bio) to compare the DASH SARS-CoV-2/S Test primer and probe sequences for the N1 and N2 assays and the sequence specific capture probes as of February 17, 2022. The predicted frequency of RT-qPCR oligonucleotide sequence mismatch is summarized in Table E. The sequence specific capture probes were also mapped on the sequences, and the predicted oligonucleotide sequence mismatch frequencies are summarized in Table F. No significant oligonucleotide mismatch with either RT-qPCR assay or sequence specific capture probes were observed with the Delta variant sequence analysis. One Omicron mutation that impacts both the N1Cap2 capture probe and the N1 reverse primer and a second mutation that impacts the N1 probe was observed. None of the resulting changes to oligonucleotide Tm resulted in a decrease to below their respective hybridization temperatures.

#### Analytical Specificity/Exclusivity (Cross-Reactivity and Microbial Interference)

An *in silico* study for possible cross-reactions with related pathogens and normal or pathogenic flora that may be present in respiratory specimens (Table G) was conducted by mapping primers and probes in the DASH SARS-CoV-2/S Test individually to sequences downloaded from the NCBI database (September 01, 2021). The DASH SARS-CoV-2/S Test primers and probes target two distinct regions of the N gene, labeled as N1 and N2. The in silico analyses show no significant sequence similarities with either PCR target except SARS-CoV sequence. The N1 reverse primer has 90.91% identity, the N1 probe has 89.29% identity, the N2 forward primer has 100% identity and the N2 reverse primer has 92.59% identity. Direct wet testing of SARS-CoV in the DASH SARS-CoV-2/S Test was performed, and no cross-reactivity or assay interference was observed at the concentration tested (see below).

In addition to in silico analysis, wet testing was performed to evaluate the DASH SARS-CoV-2/S Test when in the presence of 32 viral and bacterial organisms. For the cross-reactivity, each organism was added to a DASH SARS-CoV-2/S Test cartridge with SARS-CoV-2 negative specimens in triplicate. No organism tested exhibited cross-reactivity of the DASH SARS-CoV-2/S Test at the concentration tested. The organisms, concentrations, and results are summarized in Table G:

#### Analytical Specificity (Interfering Substances)

Potentially interfering endogenous and exogenous substances that may be encountered in upper respiratory specimens were evaluated by testing inactivated SARS-CoV-2 at a target concentration of 3X LoD in triplicate. It was determined that the volume of liquid the nasal swab can hold is 100  $\mu$ l of specimen. Each substance was introduced into pooled negative human nasal matrix specimen at the concentration indicated in the table below in the specimen volume. No interference resulting in a negative result was observed in the presence of any of the substances at the concentrations shown in Table H. Biotin was found to interfere with the assay at levels above 2.3  $\mu$ g/mL.

#### **Clinical Performance Evaluation**

The clinical performance of the DASH SARS-CoV-2/S Test was evaluated using a total of 313 prospectively collected direct nasal swab clinical samples from individuals suspected of COVID-19 including those with signs and symptoms of a respiratory infection. Testing of clinical samples was performed with DASH SARS-CoV-2/S Test and a highly sensitive EUA molecular assay that the FDA has authorized for diagnostic testing of COVID-19.

The study results (Table I) demonstrated 95.9% positive percent agreement (PPA) and 98.5% negative percent agreement (NPA) between the DASH SARS-CoV-2/S Test on the DASH Analyzer and the comparator method. There were 6 discordant samples.
